- **Welcome new PAC member and new Provincial Coordinator**

The PAC would like to welcome Christian Tardi to the Committee. Julie-Ann Drosdoski was introduced as the new Provincial Coordinator.

- **COPP Logo Usage**

PAC is formulating a COPP Logo Guidelines Policy surrounding the usage of the logo with other organization or business logos, and on what items it can be printed on.

- **Signs for back of Cars**

PAC agreed to the design and material of a new sign that would be placed in the back window of a COPP patrol vehicle. The Provincial Coordinator will be ordering stock and it will notify when available for groups to request through the website.

- **Criminal Record Search & Vulnerable Sector Verification**

PAC will investigate if it is feasible to change the length of time required between the Criminal Record Search & Vulnerable Sector Verification. Currently it is two years.

- **Regional Representation Vacancies**

There are currently vacancies in the following regions: 4, 10, 11 and W1, W2.

- **Regional Map Changes**

The following regions will be changed to accommodate the current coverages by Regional Representatives:
